Our children need us



Adults are not adequately prepared to protect children and young people from changing threats.

While there are many dangers to children and young people, it is the dramatic rise in online exploitation and abuse of children and young people which alarms us.

There are 2.88 million registered accounts on ten dark web communities sharing and trading child sexual abuse material. It is estimated that there are approximately 750,000 individuals looking to connect with children and young people with the intent to sexually abuse or exploit them online at any time.

In our own recent research, 71% of children were found to spend more time on the internet on their own. As a result, more than a third of parents were worried about how to best protect them from being exploited. Without knowledge and awareness, adults are not confident about knowing how and when to act to protect children from online abuse and exploitation, leaving them vulnerable and unsafe.

We must empower adults with the knowledge and confidence to act to keep children and young people safe from abuse and exploitation in all the environments within which they interact.



Ending the trauma of child abuse, exploitation and neglect remains outside of community awareness and is not prioritised as a community concern.

Our own research shows that the community lacks all of the building blocks required to prevent child abuse and adequately act to protect children and young people from abuse, exploitation and neglect. They are not aware of the true scale and impact of child abuse. They do not believe that it is as widespread as it really is. They have a shallow understanding of how it is defined, what its components are, how it develops or the level of risk that children and young people face in their own homes. They lack confidence about when, what and why they should take action when exposed to information that children are being abused and neglected. There are still prevailing attitudes that stop them from stepping up to keep children safe. These attitudes have been there for at least eighteen years and they have not changed.

We must deepen community commitment to take action to prevent and respond to child abuse, exploitation and neglect.



Systems for protecting, caring and supporting children and young people from abuse, exploitation and neglect face increasingly complex challenges.

The incidence of child abuse, neglect and family violence continues to increase. The evolving knowledge about trauma highlights the significance of its adverse impacts on the life course of children and young people.

However, child protection and out of home care systems struggle to protect and look after children, leaving many experiencing unstable relationships, inconsistent care and exposed to health and safety risks, including further abuse and exploitation.

There is inadequate investment in locally developed and fit for context therapeutic approaches that support the healing of children and young people from the consequences of trauma.

Systems and practice have not been designed to incorporate the insights of those with lived and living experiences of trauma.

We must strengthen the capacity of systems to protect children and young people in order to ensure that responses are trauma transformative, healing informed and culturally strong.

Empower communities

Educate, resource and support communities to keep children safe from abuse, exploitation and neglect in online and offline environments.

Our goal

Our vision to end the trauma of abuse, exploitation and neglect suffered by children and young people can only be realised when communities themselves feel empowered to care for and protect every child. To do this, we will build the awareness, confidence and capacity of networks of adults to act with purpose to keep children and young people safe and advocate for their needs. In this significant work, we are guided by the heart and expertise of adults with lived experience of childhood violation, the cultural knowledge of First Nations Peoples, the wisdom of children, young people and their families, the learnings from research and the insights of practitioners.

Be powerful advocates for children's rights and needs.

> Expand our programs that support parents and carers to build strong relationships with children and young people.

Support self-determination by First Nations communities to protect, heal and support children and families.

Deliver pioneering approaches that assist organisations across Australia to safeguard children.

What is the change we aim to achieve

- Ending the trauma of abuse, exploitation and neglect of children is a sustained and central priority for the majority of the community.
- · Parents feel confident and supported in raising their children.
- Organisations are safe places for children and young people.

How we will track success

The change we seek is generational. We will measure the shift in community attitudes and motivation to take action to keep children and young people safe. We will also evaluate the uptake and impact of the initiatives that engage and support communities to respond to the needs and entitlements of children and young people with commitment and resolve, including their right to safety, family, culture and education.

Affirm and advance our common elements approach to trauma transformative practices and models of therapeutic care.



We will monitor the increasing reach of our therapeutic programs and services. We will identify and evaluate the outcomes our therapeutic programs and services achieve for children, young people and their families and carers. We will use this evidence to amplify the benefits of our approach to children across contexts and places.





Engage constructively with systems that hold power and provide knowledgebased solutions that give children and young people the relationships they need to be safe and cared for.

Our goal

The abuse, exploitation and neglect of children and young people is a complex problem which we deeply understand. We know that disconnected responses are counterproductive to children and young people. Real change requires sophisticated strategies and actions that bring individuals and organisations together in acts of resistance to reductionist worldviews. And because we work across many systems and communities, we must be oriented to and capable of working within complex and dynamic systems of knowledge, policy, organisational structures and operational applications. We will lead the way as a valued and respected facilitator of resourceful strategies that keep the rights and needs of children and young people at the heart of our response.

Embed the rich and full participation of children and young people in the design and review of services and systems.

Help individuals, families, communities, businesses and governments know how to act in the best interests of children and young people.

Develop our people, systems and services to better embrace and respond to complexity in its many forms.

What is the change we aim to achieve

- Child abuse, exploitation and neglect is understood as a complex but solvable societal problem that requires integrated and intersecting forms of knowledge and action.
- Children and young people are supported to fully participate in all aspects of our work.

How we will track success

Our contribution to complex challenges and systemic change will be sustained and deliberate. We will track our leadership and influence in improving outcomes for children and young people. We will evaluate the effectiveness of our internal culture and organisation to respond to the complex needs of children and young people in the many contexts and jurisdictions in which we work. We will evaluate the effectiveness of our knowledge mobilisation efforts.



Mobilise knowledge for purpose

What is the change we aim to Expand our knowledge sharing and achieve

• Practitioners, organisations and governments use relevant knowledge to improve the ways services and systems are designed and implemented so that they better meet the needs of children and young people affected by trauma as a consequence of abuse, exploitation and neglect.

• We have effectively contributed to an Australian knowledge-base that is fit for purpose.

How we will track success

We will measure the collective reach, growth in engagement with and impact of our knowledge translation and capability building activities. We will also track the evolution of our knowledge base and its contribution to the field of practice with children, young people and their network of important adults. We will evaluate the inclusiveness of our knowledge to ensure it reflects the voices and histories of the children. young people and adults who are important to our work.

Our goal

We create, translate and share knowledge to shape and influence the decision-making and practice of individuals, services and governments to best meet the needs of children and young people who have suffered the trauma of abuse, exploitation and neglect and/or may be living in out of home care. We connect to a global community of expertise to advance that knowledge. Our aim is to build the capability of practitioners across contexts to support children and young people with compassion, kindness and optimism. For us, the contest of ideas, pursuit and mobilisation of knowledge is fundamental to achieving better outcomes for children and young people.
